Hi everyone,

My name is Michele McAleer, and I am a veterans caseworker in Salem, Oregon, and I am trying to assist a veteran with some VA issues. The veteran, James "Jimmy" Kasanos was a patient aboard the USS Repose, he believes in April, 1968, and is looking for any information available about a possible explosion and fire.

He believes the fire was on the aft deck, near the fantail, and that soldiers were being evacuated into lifeboats (for those of you that I have written individually, please forgive the repetition;). James was a patient in the psych ward, or "lock-up" as he called it, and would have been there after being brought in from the 458th Transportation Co (river boats), and may have had extensive issues ranging from an assault in basic training to deaths witnessed while in Vietnam.

James recalls being let out of his cell, and assisting a Ltcdr Sears with helping patients into lifeboats. During the incident, he claims that a Marine, poss named Al Capone (of Dominican descent) was being brought out by two corpsman, when he broke loose and ran back in the ship. He claims that he was the person who ran back in after him, and got him out of the ship, but when he has tried to research the incident, he can find no record of it. He says that his memory of the date is a little fuzzy, but the incident is clear, and he would greatly appreciate any info that any of you could provide.

Thank you all, for taking the time to read this, and for your service, especially. I was an Army medic myself (91-95), and I really enjoy the opportunity to help another veteran. I look forward to hearing from all of you,

I polled all former 458th members on the net and none remembered your father or the incidents he mention. All former members came to one conclusion. Lies!

I was the 458th supply sgt for two years, As for your father being close to death. This I feel sorry about, however a year ago I received a report that he was near death then. If you believe any of the stories your father claims as true then you are a fool and know nothing of the military. In the military events can be covered up, but you can not stop enlisted men from talking. Any such stories as these would have sparked a ton of rumors.

I was stationed at FT Ord the same time as your father claims to have been, the stories about Ft Ord are more bullshit.

There is more than some doubt in my mind that your father was ever in the 458th. Do you have any proof? military records, even a picture of him with any 458th equipment?

If you dislike my barnyard language, that's tough as I'm nothing but a old country hick.
